

Range Rules and Facility Usage

All weapons must be unloaded and in a case or holster to enter this building.

CCDW permit holders may carry their weapons concealed, if they so wish.

Rifle shooters must be 18 years of age or older or accompanied by parent or guardian.

Handgun shooters must be 21 years of age or older or accompanied by parent or guardian.

One child per parent/guardian on the range.

Load and unload all firearms in shooting stalls only, weapons pointed downrange.

All weapons must be pointed downrange at all times.

Do not exchange loaded weapons with other shooters. Switch lanes, not firearms.

No one is allowed beyond the firing line for any reason at any time.

Tape targets to carrier board. Aim weapons such that you strike the backstop area.

DO NOT SHOOT THE FLOOR, WALLS, CEILING, TARGET CARRIERS OR LINES.

DAMAGE TO RANGE SUBJECT TO REIMBURSEMENT FOR REPAIR AND LOST REVENUE.

No quick draw or "hip" shooting at any time.

No more than two (2) persons are allowed per shooting lane. NO EXCEPTIONS.

No food, drink, or tobacco use on the range.

Management has the right to remove anyone from the store, range, or grounds for safety or any other concerns, at Management discretion.

NO TRACER, INCENDIARY, ARMOR PIERCEING OR STEEL SHOT ALLOWED ON THE RANGE.

You may take your own fired casings with you. Do not remove casings from buckets.

Sweep unwanted casings forward of the firing line or into buckets.

Please put all trash in trashcans. No casings for unfired ammunition in trash cans, please.

SHOTGUNS ARE LIMITED TO SLUG AND #4 – 000 BUCKSHOT ONLY.

No calibers or ammunition over 3600 feet per second on range.

Rental firearms must use Shooter's Supply ammunition only.

Rental firearms lost, stolen, or damaged, beyond normal usage, are subject to reimbursement up to retail replacement price.

Return rental weapons to Shooter's Supply employees unloaded, with breech locked open.

No pregnant women are allowed in the range area, for the safety of the baby.

Management may expel anyone suspected of being under the influence of any substance.

DO NOT BRING LOADED OR JAMMED FIREARMS OUT OF THE RANGE.

Valid range cards must be presented to use the range. Replacement cost - \$5.00.

Suitable eye and ear protection must be worn on the range at all times.

All firearms and ammunition are subject to inspection by Shooter's employees at any time.

Shooter's reserves the right to prohibit any weapon or ammunition at any time.

NO REFUND OF ANY KIND WILL BE ISSUED TO PERSONS EXPELLED FROM THE RANGE

Release and Waiver Agreement

The undersigned agrees to follow all instructions and commands given by the employees and management of SHOOTERS SUPPLY AND SPORTING GOODS, INC. ("SHOOTERS SUPPLY") and to abide by all safety and operational rules provided by SHOOTERS SUPPLY, including safe firearm handling procedures and the use of proper hearing and eye protection. The undersigned acknowledges and understands that there are dangers and risks involved whenever firearms are used, and that the use of firearms may expose him/her to the risk of injury even when precautions are taken. Therefore, in consideration of the use of the facilities at SHOOTERS SUPPLY, the undersigned, his/her heirs, next of kin, executors and administrators, hereby agree to hold SHOOTERS SUPPLY, its employees, agents, and insurers harmless from any and all demands, rights, causes, or action of whatever kind of nature arising out of all known and unknown, foreseen and unforeseen bodily and personal injuries, including paralysis, damage to property of any kind, and the consequences thereof including death, resulting from the undersigned's voluntary use of the facilities of SHOOTERS SUPPLY.

The undersigned hereby warrants that he/she has been trained and instructed in the proper and safe use of firearms by a qualified instructor and that he/she is familiar with the operations and characteristics of the particular firearm(s), that he/she will be using at SHOOTERS SUPPLY. The undersigned further warrants that he/she has been instructed in the use of firearms ranges, including, but not limited to, operation of the target(s) and acceptable conduct when using the firearms range with other persons, but that lack of training or instruction shall not in any way limit the scope of this Release and Waiver Agreement.

By signing this Waiver, it is the intention of the undersigned to release, waive, and indemnify SHOOTERS SUPPLY, its employees, agents, and insurers from liability connected with the undersigned's use of the firearms range and other facilities of SHOOTERS SUPPLY, including, but not limited to, the negligence of SHOOTERS SUPPLY and any of its employees, and/or agents, and to personally assume all risks of personal injury of any kind, death, or property damage. The undersigned acknowledges that he/she has signed this Waiver voluntarily and of his/her own free act. If any part of this waiver is held unenforceable, such part shall be stricken and the remainder of this waiver shall be construed according to the laws of the Commonwealth of Kentucky.
